जयपुर . मुख्यमंत्री भजनलाल शर्मा ने शनिवार को कोटा संभाग और जयपुर ग्रामीण लोकसभा क्षेत्र के विधायकों, विधायक प्रत्याशियों से बजट और एसआइआर को लेकर चर्चा की। बैठक का नाम तो बजट पूर्व चर्चा ही दिया गया था, लेकिन ज्यादा चर्चा एसआइआर पर रही।

सीएम आवास पर आयोजित बैठक में मुख्यमंत्री ने बजट पर सुझाव लिए और एसआइआर पर सजग रहने के निर्देश दिए। बजट को लेकर सीएम ने कहा कि आगामी बजट पीएम नरेंद्र मोदी के ज्ञान संकल्प से प्रेरित होगा, जिसमें गरीब, युवा, अन्नदाता और महिला घोषणाओं के केंद्र में रहेंगे।
