Performa for on-line entering the various information's with respect to Election Planning is also attaching with this letter as annexure-II. This information should be also updated by DEOs concerned from their account in Citizen Portal of ECI.

Please complete both the exercise latest by 10th October 2013 positively and send a compliance report to this Department without fail.

Verification of latitude and longitude of all polling stations of your district:

It is also informed by the Commission that latitude and longitude of few polling stations of some assembly constituency of State are wrongly updated in ECI portal. It is also come to the notice that location of some polling stations of Barmer district showing outside the country due to wrong updating of latitude and longitude of these polling stations.

Therefore, you are requested to verity latitude & longitudes of all polling stations of your district one again carefully and ensure that this time these are update cent-percent correctly. After updating of verity latitude & longitudes of all polling

stations of concerned constituency, you should check it on Google Map to ensure that none of polling stations locations showing outside of AC boundary. After verification of all polling stations of your district, you are supposed to submit a certificate to this department that "Locations of all polling stations of all constituency of your district is showing under the boundary of concerned constituency".

Please complete this exercise latest by 20th October 2013 and send a compliance report to this Department.
